Consumer Directed Attendant Support Services (CDASS)

CDASS will allow for Personal Care, Homemaker, Homemaker Enhanced, and Health Maintenance services to be self-directed for persons receiving the Supported Living Services (SLS) waiver only. The Attendant to provide services is selected by the person in services or their authorized representative (AR), and the client/AR maintains the right to hire and terminate the Attendant at their own discretion. Training is supplied through Consumer Direct Colorado, and the Attendant is paid by a Financial Management Service (FMS) agency through the SLS waiver, and the FMS is also self-selected.
